DECLARATION OF RESULTS

I hereby decalre the final results of the InternetNZ 2018 Elections, which closed at 5pm on Thursday 26 July 2018, as follows;

Election of ONE (1) Councillor to the InternetNZ Council

Total Valid Votes 134 Total Invalid Votes 0 Winning Threshold/Quota 68

After the tallying of all preferences, the successful candidate was Richard HULSE.

The unsuccessful candidates are Vivian CHANDRA, Dianne DANIELS and Rochelle FURNEAUX.

Motion 1 - 2018 proposed change to the Constitution

THAT Clause 11.4 of the Constitution be changed from: "In all elections a preferential voting system will be used." to "In all elections a preferential and proportional voting system will be used."


