### 1 - Meeting preliminaries

Whitiaua Ropitini, Principal Adviser Kaupapa Māori opened the meeting with karakia.

The President and Chair of the meeting, Stephen Judd welcomed eligible members to the meeting in the Zoom video conference and those members observing via live stream.

President Judd introduced Anjum Rahman (Vice President), Kate Pearce (Councillor), Vivien Maidaborn (Chief Executive) and Vivian Chandra (Facilitator).

The purpose of the meeting is to discuss and vote on a motion to reregister a revised Constitution that is compliant with the Incorporated Societies Act 2022.

## Motion 1

**That the Constitution be adopted as the Constitution of Internet New Zealand Incorporated, to take effect on the society's reregistration under the Incorporated Societies Act 2022, as soon as practicably possible after adoption.**

As the majority of those who voted (85.25%) voted FOR Motion 1, Motion 1 was declared carried.

50.41% of eligible members voted. (183 votes received from 363 eligible members.)

**Following the adoption of the Constitution, that the alternative options shared with eligible Financial Members for consultation on 7 March 2025 be brought to the 2025 AGM.**

### Results

AGAINST	75
FOR	35
ABSTAIN	1

As the majority of those who voted (68.18%) voted AGAINST Motion 2, Motion 2 was declared not carried.

30.30% of eligible members voted. (110 votes received from 363 members.)


## Closing
