SeniorHangouts, our online virtual Learning Centre has been in hot demand during the first pandemic lockdown in 2020, and even more so now we are in a further major lockdown in August/September of 2021. Our 56 physical learning centres are unable, and unwilling to open until we reach a safer environment and thus, SeniorHangouts has become a "lifeline" for many seniors who are isolated, locked in, living in retirement villages without visitors, and just desperate for human company. Our sessions are currently twice a day in English and we are providing two sessions a day in Hindi for an affiliated Indian membership organisation. Since early 2021 we have been developing an app which brings together, in one place, registration, a library for storing and retrieving content, a classroom and a community forum. While the app is still under development we are incorporating a registration form which will form the basis for our evaluation methodology.

In addition to securing funds from InternetNZ to implement an evaluation methodology we have secured a major relationship with Google.Org. The support of InternetNZ for the evaluation project will also assist us with the reporting required for the Google.Org grant.

What are the outcomes of this initiative so far? *

Although the funding is for the evaluation of our SeniorHangouts project, it is helping us to start discussions with our Board regarding the importance of evaluation and how we might further implement an evaluation methodology with our physical Learning Centres. The Board has been keen for us to action a national roadshow to communicate this, and other national issues to encourage and motivate our Learning Centres. In the past we have collected demographic data and feedback and in 2008 there was a major review of our activities but there is no ongoing formal evaluation, except for collecting narratives.

We have been delayed in finalising our SeniorHangouts app development because of Covid and we have not yet completed the registration form which will be the starting point for our evaluation process.

That collecting feedback is not the same as evaluating our outcomes. That this project has thrown up a lot of internal challenges. Our focus in the past has been about teaching with an internal focus - "did we teach this course well?". Now we are trying to focus externally by asking the participants "what can you do now that you didn't do before?"

We have started to look at how we attract people to our Learning Centres; the messages we use; talking about outcomes, rather than outputs. In the past we have asked people to attend "lessons" i.e. "File Management" - now we are trying to convert our Learning Centres to talk about the outcomes - "learn how to sort your photos".
