DNA established a formal partnership with Media Design School, InternetNZ funding was to allow our tutor to work alongside students enrolled in this course. Due to Covid, and delays from TEC to confirm our partnership - we had to delay our initial intake. As a result we iterated on this programme slightly and what we have done is create a cohort of 28 students in a mix of animation/creative tech classes to staircase a group of them into the Feb 2022 intake. We hope to bring in 10 of this group - with 5 more joining us during the next intake when they are old enough to enroll (16+)

**What are the outcomes of this initiative? \***

We have worked with 28 students over a range of animation, illustration, video editing classes (intermediate to advanced) to help them prepare for their first year of tertiary study. While not all are going to enroll (mostly due to age restrictions - must be 16+) we now have a group who are ready to enroll in their first year of tertiary study. We have confirmed to date that at least 10 students will be enrolling in Media Design School's Foundation Course for 2022.

We have held an open day in which MDS attended - over 30 students and their families attended.

Instead of 6 months - we extended to 8 months, 4 days a week for 4 hours a day, this increased our in-kind funding. We removed the need for a coordinator - this job was done on a voluntary basis.
