We have a formal partnership with Media Design School, this funding was to allow our tutor to work alongside students enrolled in this course. Due to Covid, and delays from TEC to confirm our partnership - we had to delay our initial intake. As a result we iterated on this programme slightly and what we have done is create a cohort of 28 students in a mix of animation/creative tech classes to staircase a group of them into the Feb 2022 intake.
