In the last 10 months, considerable progress has been made as planned in the proposal since the activation of the project in April 2020. The main work that has been completed includes:

Ethics application approved: The ethics application for the first stage of the project was approved by the AUT Ethics Committee.

Literature review: A systematic literature review has been conducted in the related area, which provides an overall picture of the research questions of the project. This is ongoing.

Data collection & analysis: Based on the systematic literature review, a semi-structured interview guide has been developed to facilitate the first stage of interviews. Until now, 23 interviews have been conducted with the owners of small migrant business owners. The qualitative data has been analyzed through thematic analysis.

Overall, the progress of the project proceeds well as planned in the proposal despite the actual number of interviews (i.e., 23) is slightly lower than the planned (i.e., 30). This was due to the challenge to hire a research assistant in Wellington for participants' recruitment, and the unexpected restrictions and lockdown of COVID 19. However, the data analysis demonstrates that data saturation has been achieved among the current interviewees,

which can ensure the validity of research findings from the first stage of the project. A few more participants that have shown interest in participating the project will be followed up.

Based on the literature review and data analysis results, a survey that aims to approach a wider scope of migrant small business owners is currently under-development and it will be conducted online after gaining ethics approval in the near future. In short, the project has achieved the first three key milestones proposed in the proposal.

What are the outcomes of this project so far? *

Emerging findings are identified from the first stage of the project:

Most of the participants believe that “No Internet, no business”. The value of the Internet is widely recognised, which is proposed to be important in assisting business productivity, profitability and performance. Wi-Fi, computer, phone, email, and social media (e.g., Facebook) are proposed to be the most widely used service. Most participated business owners have the ability to use them. The value of the Internet is further highlighted by COVID. Many interview participants reach the agreement that COVID makes them realize the importance of the Internet. It is identified that the COVID has promoted the development of digital marketing, online booking system, and new online business models, which is interesting and valuable for the further implementation of the Government’s Digital Inclusion Vision.

Business owners are forced to adapt to the internet era before they are ready. The initial findings demonstrate that many migrant small business owners are forced to adapt to the use of the internet, digital marketing, online booking system and new online business models in the COVID period. Many of them expressed that they “have to” use such services although they don’t have the skills and knowledge.

In terms of the investigated business owners’ readiness of using internet-based service, the first stage of data collection identifies that it varies, which largely depends on the business owners’ education background and skills. But one of the common challenges that emerged is the lack of budget or investment.

The initial findings provide valuable directions for the next stage of survey design, and will be further verified by a wider scope of participants. The findings have provided several interesting evidence-based insights for the implementation of digital inclusion initiatives supported by InternetNZ.

Describe major achievements of the project so far in terms of benefits for participants and/or others.

What have you learnt so far? *

The aim of this project is to investigate the level of readiness to use internet-based services for the migrant owners of small businesses. So far, the project has provided a great opportunity for the migrant small business owners to ‘have a voice’ about the challenges they are facing when using the internet, something that is particularly important in the post-COVID period. Their input is vital to the government and other organizations’ as they develop policies to assist business owners to make the most of the full potential of the internet in a post-COVID environment.
