## Please provide a short summary of the work that has been completed as part of this project/research

Since the activation of the project in February, 2019, we have developed the ethics application and had this approved through the University of Auckland Human Participants Ethics Committee. We have established cultural and youth advisory board We have collected literature and read extensively in the area and are over half way through data collection for Phase One of the project (with 23 individual interviews out of a total of 30-40 completed).

We have also been successful in obtaining a Marsden Grant for work in a complementary area. The Marsden funded research will investigate young people's engagement with mental health issues on the internet more broadly but has obvious synergies with the current project and will contribute to its development.

While we have made considerable progress on the project, we are approximately three months behind on our deadlines for data collection and analysis. This was as a result of the researcher experiencing unanticipated health problems in the first half of 2019. We requested and were granted a three month extension on the deadline for this project to 30 April, 2021.

The restrictions surrounding Covid19 have impacted on our progress in recent months and are likely to continue to do so for some time. We have chosen to conduct interviews via an innovative digital messenger interview process which allows us to continue to do some interviews while adhering to social distancing requirements. However, we have not been able to recruit as effectively through organisations such as schools and clubs during this

We have chosen to the individual interviews using WhatsApp instant messenger as this has, in our recent research, prove to be a better fit for young people and particularly useful in capturing their online practices which can be communicated through screenshots as well as digital descriptions. In addition to its research benefits it also allows us access to interviewing through this period of Covid19 restrictions.
