Freedom of speech on the internet – where do we draw the line? This question is read only.

Please provide a short summary of the work that was completed as part of this project / research *

The objective of this research was to aid understanding about the ongoing debates relating to freedom of speech on the internet at a time of rising concern about negative online behaviour such as hate speech. Conducted mainly during my time as a Visiting Fellow at the Oxford Internet Institute, UK, the project involved the gathering of scholarly literature about freedom of speech, negative online behaviour, internet regulation and an emerging field of online counterspeech. Analysis of data involved the linguistic examination of online counterspeech in response to overt racist comments on a YouTube platform and resulted in the identification of a taxonomy of counter speech initiatives used by commenters. The intention is to develop this work further to educate and inform internet users about effective ways in responding to negative online behaviours. But it also provides insights into discussion about internet regulation and free speech as well. The preliminary findings were presented to other academics (staff and students) at the universities of Swansea, Lancaster and Oxford during 2019 and more recently has been written up for publication.

Data analysis	My time at the Oxford Internet Institute gave me the opportunity to work on this research which was a new area of interest for me, but one that was relevant and topical both within academia and beyond.

Networking and presentations	I was invited to give presentations about my research at three universities in the UK (Oxford, Swansea & Lancaster). In addition I was able to expand my academic networks amongst the internet research community. Being located in the UK enabled me to meet others with similar or overlapping research, attend stimulating talks eg weekly presentations at OII, Reuters Research Institute on online journalism, and a lecture by Vint Cerf at Oxford University.
Outputs	I published an opinion piece emanating from my building of knowledge about free speech online in relation to the recent Christchurch attacks. I also completed a paper for submission to an academic journal on my research.

What (if anything) did you change in your approach and practices as your project? research proceeded, and why? $\mbox{*}$

As a result of my scholarly investigation into the tension between hate speech and freedom of speech in online environments, I discovered that counterspeech was an under-researched area and decided a focus on this could lead to emancipatory outcomes. I found this to be significant because of the current global discussions about internet regulation between tech

companies, governments and free speech advocates. Analysis of different counterspeech initiatives in responding to online abuse was worthy of further investigation because it offers an alternative to the deletion of material through internet regulation which is an ongoing topic of debate. The analysis of the data was more time consuming than anticipated as I was the sole researcher. I see this work as an ongoing project along with other researchers in developing counter speech strategies that can be used to assist people in developing their digital skills when it comes to responding to negative online behaviours.

What did you learn as a result of undertaking this project/program? *

Conducting my research while on research and study leave at an overseas academic institution (i.e. the Oxford Internet Institute), away from the distractions of teaching and administrative work in New Zealand, went well beyond my expectations. In Oxford I had the opportunity to meet and network with a wide range of academics with similar interests. This not only brought new insights to my work, but also enabled me to contribute to the research culture there. It also drew attention to New Zealand, research, my university (AUT) and InternetNZ. Although the financial cost of being based at Oxford was high (accommodation/ overheads/travel), this stimulating environment had multiple benefits as I was able to attend lectures/presentations of leaders in their field and had access to many different libraries and resources. I also received useful feedback on my work. Although not part of my project, lectures to postgraduate students at OII that I attended provided me with ideas and possibilities to introduce into my own lectures on internet phenomenon and new media at AUT. As far as the timing of my research goes, the unanticipated event of the attacks on the Christchurch mosques meant my project's relevancy and significance were heightened. I was able to contribute to the public debate through the publication of an opinion piece on The Conversation website which has a global audience and inspired discussion and debate through the comments section. Overall I see the research, conducted with the support of InternetNZ, as heralding the start of my work in this new field of counter speech and which I intend to develop further. It provides opportunities to inform decision and policy makers, media and other groups interested in this topic.

We are particularly interested in lessons that may help others undertaking similar work. How will you share your learnings from this project/research? *

I was able to share my initial research findings at three universities in the United Kingdom during my time there. I have already had one publication of an opinion piece that draws on my research and thinking about hate speech and free speech on the internet, and an article for a academic journal has been submitted. I intend to present my work in New Zealand and I am also contributing to the dialogue on ways to support the implementation of the Christchurch Call to Action hosted by InternetNZ. In September 2019 I will be on a panel (Global Discourses (and Counter Discourses) of Hostility in the Social Media Age, at the 5th European Society for Transcultural and Interdisciplinary Dialogue in Italy. My intention is to draw together academics across disciplines with similar interests to build a more comprehensive and connected field for counter speech research. The findings from my project therefore have reached a wide audience covering academia and the wider publics.
