Freedom of speech on the internet - where do we draw the line?

Work completed so far as part of this research includes the gathering of scholarly literature about freedom of speech as well as articles that offer a range of perspectives about what qualifies as negative online behaviour. I have been analysing two different sets of data. The first set relating to counterspeech initiatives used by commenters in response to racist comments on a YouTube site is currently being written up as a paper with the intention to submit it as part of a themed issue on the dark side of social media to an academic journal along with other authors from Europe, Japan, Taiwan, Slovenia and Cypress. I have prepared and given three of the five invited presentations to academics and students in the UK while I am here as a visiting scholar at the Oxford Internet Institute. <p>The preliminary analysis of two data sets of negative online behaviour</p>	<p>This involved the close reading of data and detailed linguistic analysis not only of offending online material but also of the counterspeech initiatives that people made in response. The current data I am analysing comes from the following sources:</p> <ul style="list-style-type: none"> <li>(i) comments beneath an anti-racism YouTube video;</li> <li>(ii) abusive comments sent to women journalists in New Zealand via text, email and social media (note that this data has been collected in conjunction with Dr Helen Sissons, senior lecturer in journalism at AUT, who has conducted ethnographic observations and interviews with journalists in newsrooms).</li> </ul>
<p>Three academic presentations have been completed since the beginning of September here in the United Kingdom.</p>	<p>These presentations are as follows:</p> <ul style="list-style-type: none"> <li>(i) British Association of Applied Linguistics Annual Conference, held at St John's University, York, UK, 6-8 September, 2018. <p>Networking, connections and knowledge building</p>	<p>Along with my research activity while attending the Oxford Internet Institute as a Visiting Scholar, I have been fortunate to have the opportunity to interact with many different researchers coming from different disciplines (staff and students) who have an interest in various internet phenomena. There are several talks each week in Oxford that have relevance - eg data protection, AI, or cognitive biases through mobile gaming and these will be influential in my AUT teaching on the Masters in English and New Media degree. The highlight for me so far has been to meet Vint Cerf who came to the OII on 6 Nov (in advance of NZ). I had the opportunity to ask him questions as well as to attend his main public Romanes Lecture in the Sheldonian theatre.</p>

**What findings have you made so far?**

Findings so far include:

- (i) Numerous labels have been assigned to the many different types of negative behaviour that pervade the internet. This fragmentation makes it more difficult to assign what should be regarded as free speech and what should be taken down if that were an option.
- (ii) Counterspeech can be an effective way to counteract negative online behaviour as an alternative to deletion which may impinge on free speech. However there are some strategies that are more effective than others and some counterspeech initiatives can be counterproductive.
- (iii) Satire, humour and anger are dominant in a number of online comments and initial comments tend to set the tone for others.
- (iv) People appear to be more aware about the potential to fight back against online abuse.

**What (if anything) did you change in your approach and practices as your project/program/initiative proceeded, and why?**

My overall approach in investigating the tension between hate speech and freedom of speech still stands in this project as planned. The analysis of the data so far has been more time consuming than I anticipated particularly in negotiating the discourse between commenters and identifying their discursive strategies and response types using linguistic analysis. Nevertheless some interesting findings have already arisen which provide some interesting insights for further investigation. I am finding that counterspeech is an under-researched and under-theorised area so am pleased with what I am able to contribute both in my research and in my presentations.

The funding agreement indicated a total expenditure of \$20,752 so there is a difference of \$52. There has been some variance in the amounts relating to Oll overheads - \$153 more (impacted by the exchange rate and bank fees) and accommodation (\$205 less than anticipated). But the personal funds contributed by the researcher have been adjusted to accommodate these minor fluctuations. Travel and accommodation for my visits to talk at the Universities of Swansea and Lancaster have been covered by these institutions.
