At the time of submitting this report, InternetNZ has funded transcripts of 32 Mosen At Large podcast episodes so they can be available to Deaf Blind people who otherwise would miss out on the information and community participation for which the podcast has become known. Because of the range of accents and occasional use of text-to-speech for technology demonstrations, it was important that these transcripts be human-generated. Technology has not yet advanced sufficiently for AI to be viable for this use case.

Are there any areas where you need further support to complete this mahi? This podcast series is ongoing indefinitely, so it is my hope that we will find funding to continue to make transcripts available for Deaf blind people in future years.

#### What are the outcomes of this project? \*

Deaf blind people have access to the information the podcast offers, including assistive technology updates and discussions about issues topical in the blind community. Having gained access to the podcast, they are then able to email their own contributions into the podcast for inclusion. This has allowed the podcast to offer a perspective that is not often heard. It has changed the nature of some of the discussion, for example we have had useful discussions about the impact of cochlea implants for Deaf blind people. It is an example of the Internet bringing an often neglected and disadvantaged group together.

I am pleased to say that the availability of transcripts on Mosen At Large has set a new high bar and caused other blind podcasters to consider how they may be able to include the Deaf blind community.

Describe major achievements or outcomes of the project in terms of benefits for participants and/or others.

#### Who have you worked with to make this project happen?

After careful research, we are using a service called GoTranscript.com. Their transcripts are not letter perfect and require manual editing once received, but they are cheaper than Rev.com, whose pricing I used to estimate costs in my application. This means that I should be able to make the InternetNZ grant last for a full year. GoTranscripthas a loyalty discount, which also helps. For transcripts that are timesensitive, such as when Microsoft announced Windows 11 and Apple announced new software and hardware, we can pay extra to fast track them and have them published within around 10 hours. This gives Deaf blind people access to impairment-specific information in a timely manner. This is unusual and has been welcomed.

We may use this information to help inform others undertaking similar work.

What did you or your team/organisation learn as a result of doing this project? \* As I expected, there is a hunger among Deaf blind people who sometimes don't quite know where they fit. Since blind people tend to rely on audio and Deaf people use Sign, people feel like they don't fit easily in either world and are often overlooked. Being able to connect with the blind community in this way means a lot to people. At the beginning of every transcript, I note that it is possible thanks to funding from InternetNZ. Several readers have written to me specifically asking me to thank InternetNZ for their kindness.

While the transcripts are human-generated, they still contain inaccuracies. I think this is caused by the range of accents (we have listeners and contributors from all over the world), as well as blindness-specific terms and products with which most people aren't familiar. Ideally I would like to be able to spend less time manually editing the transcripts, but at the moment this is the best balance between making the funding last and getting the product out quickly.

In an example of accessibility benefiting everyone, some people have commented that they
