Provide a summary of the work undertaken. *

A comprehensive website accessibility assessment was undertaken across four organisations including TechMate, Hoon Hay Community Association (HHCA), Qtopia and Shirley Community Trust.

This assessment occurred in consultation with key stakeholders including website owners, their users, people with lived experience of a disability and technical specialists (user experience specialist [Tait Communications], website developer, a person with a special interest / qualifications in human and technology interface and speech language therapist). Their input formed part of the overall review, and a comprehensive report was created in both 'layman's terms' and technical language. This report supports organisations to understand the changes required to improve website accessibility along with a range of recommendations for their consideration. These organisations were given the option of engaging TechMate to implement the recommendations or employ a website developer of their choosing. We have additional not-for-profit organisations such as Volunteering Canterbury, Halswell Community Centre and Manuka Cottage who we will continue to engage with over the upcoming 6-9 months.

In addition to the above mahi, our staff attended a workshop facilitated by Will Soward (Tait Communications), prior to commencing this initiative. TechMate Team and volunteers have been trained in Squarespace and general website accessibility to enable them to update our website and others running on this platform.

What impact has this work had? *

Ordinarily community and charitable organisations have insufficient funds to undertake a website review of this scale. This grant has enabled several organisations to obtain the information and resources necessary to make changes that will significantly improve the accessibility of their website and potentially engage more people with their services. The mahi undertaken with this grant will also benefit the people accessing these sites in terms of obtaining the information they require and give them confidence to access this information online.

This mahi has also given our staff and volunteers valuable training and hands on experience in website review and development that they can continue to use in future projects.
