The co-chairs/chairperson needs to have the mandate of the membership to speak on their behalf.

This does not appear to be an option, but I would be in favour of having co-chairs elected, and where this is not possible (e.g. there are no Māori candidates for co-chair standing) then the Chairperson should be elected, with the Deputy Chairperson appointed by the Board. As it is not available as an option, I will choose the next closest alternative.

So that might be global internet governance systems or cyber security for example.

Overall - it does seem the InternetNZ Council has strayed outside of its Governance responsibilities. So it makes sense to trim it down and focus more tightly.

I have no objection or preference, but note that the claim "Therefore the Chair/s hold no additional obligations and powers" is not strictly true, as the board meeting chair holds a casting vote (3.4.3).

I do have some concern that co-chairs may diminish the chair (current president) as a public face of the organisation, relative to the Chief Executive.

My interests are in democratic accountability and transparency of organisations exercising a public function, as InternetNZ purports to do. Numerous other aspects of the draft are regressive in this regard, especially:

- Electronic voting and meeting attendance should always be an option for all General Meetings. As written, it is only one possible way the chair may decide to conduct a meeting. This is regressive.
- 4.1.1 all meetings should be online. In-person should be optional.
- 4.1.4 all members should be able to attend (why not?). Eligible members should be able to vote and speak.
- 4.1.8 electronic voting must always be available. Otherwise this is a significant regression on the old constitution. Other methods are optional.
- 3.4 Board meetings should be required to be open to members to observe, except when considering very limited matters requiring confidentiality. This is current practice; it should be required.

- 8.2 The interests register should be available to members.
- 8.3.3 The society should only be able to refuse to supply only for the reasons in s81(1) s81(2) should not apply.

- 3.9.1 appointed board members terms should end at each AGM. the new elected members should decide whether to reappoint them. Elected board members should not be stuck with a previous board's choices of appointed members.
- 2.8.1 appointed board members should not be able to vote to suspend membership. I'm not convinced members should be suspended at all before dispute resolution.

Do not include this. Internet NZ is broader than .nz and .nz is entrusted to INZ but is not our exclusive property.

I'm not necessarily opposed to the content of the proposal - but this is not the place for it. Nor is it appropriate to try and apply pressure against .nz via the parent constitution.

.nz policy must follow the prescribed .nz policy process and it is not appropriate for inz or its membership to bypass this process and thus exclude many thousands of general stakeholders such as registrars and registrants.

If .nz delegation is lost this would actually make it so that this rule no longer applies. It would only apply so long as internet nz is managing and this is frankly bizarre.

Further, if .nz policy and internet nz constitution contradict I would argue we are bound to follow the .nz policy and not our constitution. We sell domains and sign contracts and make MOU under the .nz rules. Not our constitution.

Again not necessarily opposed to the intent although this is not specified well enough for a modern and versatile domain rule set. If we decide what people do with domains isn't our problem in the slightest we risk setting ourselves up for a Wild West where we lose government and public trust, malware and phishing runs rampant, and we are powerless. I oppose censorship, and support appropriately developed policy to prevent this. But I also oppose overly dogmatic interpretations of the technolibertarian ideals of the nineties which do both take into account the actual challenges of today and needs of our local internet community.

Make rules for our cctld the right way. This is not the right way and is an undemocratic attempt to bypass the broader multistakeholder approach via the views of a narrow subset. This is not appropriate and possible in breach of many obligations we have both from rfc, MOU, contracts, precedent, and our own stated PDP.

The constitution may be making a fundamental mistake in centering .nz. The existing constitution does not mention .nz at all, because it is about the purpose and structure of an incorporated society that exists to advance a broad vision for the Internet. That breadth makes the existing constitution robust - if InternetNZ lost the delegation to be NZ's ccTLD, the existing constitution would still set out vital and worthy objects for it to pursue. The proposed constitution centres .nz in the objects, making the mission and vision narrower and more fragile, and potentially creating legal risks. I encourage everyone involved to look higher and think broader - the Internet is much more than the domain name system, and the focus on .nz is InternetNZ losing its way.

Even within the .nz domain space, there is an unfortunate lack of vision and action. Where is the embrace of modern platforms that centre domain names like Mastodon and Bluesky? Where is the analysis of threats to efficient and open-ended use of domains from centralised control by corporates and governments? Where is the toolkit to enable New Zealanders to build their own websites and escape the reaches of large social media companies? There is so much to be done here, and InternetNZ should be a forum or rallying point for this work!

The constitution should NOT include a statement on how the administration of .nz relates to content. The constitution defines and sets rules for the incorporated society, its objects, and relationships of members and board/Council members. Policy for .nz needs a .nz policy process. The proposed statement has necessarily been prepared in haste and risks being both too broad and too specific in a complicated and nuanced area.
